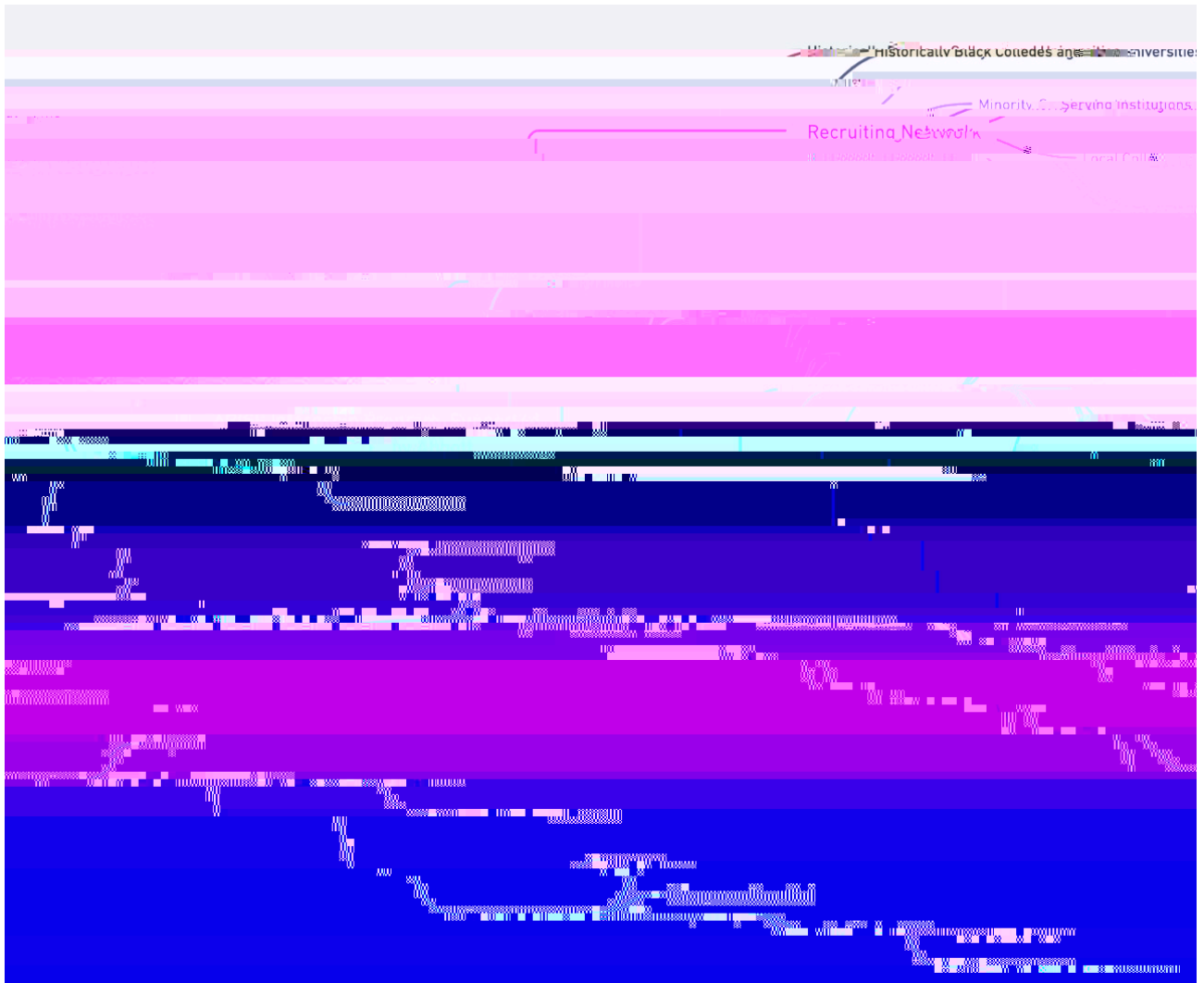


Figure 1. The ARISE Program at Norton Healthcare, supported by Abbott
